Enroll easily and quickly

2. Enter the requested information. Be sure to enter your name exactly as it is listed in the VA system.

Eligible beneficiaries include any veteran enrolled in VA health care and any individual enrolled in VA's Civilian Health and Medical Program (CHAMPVA).

Enrollment in VADIP is voluntary. Coverage starts the first day of the month after your application is received and accepted. There is an initial 12-month commitment and after this period, you can continue your coverage on a month-to-month basis. You'll pay your monthly VADIP premiums through electronic funds transfer (EFT), which you must set up when you enroll.

¹ The deductible is waived for diagnostic and preventive services under the Enhanced plan. Under the Comprehensive plan, the deductible is waived for diagnostic and preventive services provided out-of-network, and there is no deductible for any services provided in-network.

² Enhanced Plan: The waiting period is 12 months for endodontics and periodontics. Comprehensive Plan: The waiting period is 12 months for major restorative, endodontics, periodontics, oral surgery³, and prosthodontics.

³ Simple extractions (procedure codes D7111 and D7140) are the only oral surgery services covered under the Standard and Enhanced plan, and the only oral surgery services covered in the first 12 months under the Comprehensive plan.
